- Embarrass Regional Fair Association *see attached report; Sue Beaton speaks on behalf of the fair board. Motion/ Wright: Second/Fowler to approve Embarrass Regional Fair Association \$750 in labor in 2023 to help with the setting up and taking down of the fair. Unanimous vote. Motion carries.
- SISU Heritage Inc. *see attached
- Historical Tours were not held in 2021 with the Covid Pandemic and the passing of tour guide Mike Salo. Memorial donations towards future tours were received. Tours will be discussed with SISU Heritage Inc. to ask if they are interested in taking over. The \$1,192 memorial funds will be handed over to SISU if acceptance of the tours.
- Heritage Park and Campground had a great 2021 season. Lori and Roy Worsham will be returning in 2022 as caretakers. With camping patrons being turned away discussion have been had to possibly add 5 sites. Electrical upgrades are needed to keep up with the RV's. Completed work in 2021 was a water tower update and dumping station moved to the correct side of the road to make it safer and easier for the patrons. Handicap sidewalk to the shower house was installed. Reservations for the upcoming season have been

- coming throughout the winter season. Rates were increased at the 2022 reorganizational meeting. *More on campground in the attached 2021 maintenance report.
- Mike Rhein with Babbitt Ambulance Services *see attached report; passes out financial reports and speaks with those present on the costs of keeping the service operating, the equipment needed and members on call. Discussion was had on adding a charge to property owners tax statements to go towards department. Most present are in favor of having an amount added to go towards the ambulance departments that service the area. Questions and concerns were had on being charged multiple fees when more than one ambulance department shows up to residence, along with other questions and concerns. The breaking up and division of residencies and ambulance departments would need to be worked out along with several other items on the subject. Ambulance departments have a service area they service and Embarrass is serviced by 4 different departments. Twice the question was asked by present residents if Embarrass Township has ever paid any ambulance service, to which the answer is no, the township has never paid ambulance service. Babbitt residents pay a yearly thirty-dollar fee. Many felt that is a cheap price for the service. Comments were made on insurance paying for the ambulance calls. Cathy explains how insurance money is used for equipment and other needs. Motion/Lee: Second/Davies to ask town board to come up with recommendation and move forward with looking into and make good decisions to help with the ambulance service and the citizens of Embarrass. The board to consider a thirty-dollar fee per household levy to be divided amongst the four different ambulance services. Yays-9 Nays-3 Motion Carries. Concerns were voiced on the issue of a 911 call being made and more than one ambulance shows up and feel this needs to be addressed at a state level being it could be a lifesaving issue if one is needed on another call. Mike Rhein gives great compliment towards the ERVFD and wants residents to be aware of how lucky the township is to have them.

Presentation and Discussion of the 2023 Proposed Levy

Township Board levy proposal for 2023 of \$172,000 presented. Increase of 3.61% increase (\$6,000) The board felt the increase was necessary because of inflation and the transferring of funds from other funds to keep a fund account afloat. Without the ARPA funds the township funds are at a low. Larger spending in 2021 was due to new plow truck purchased. Campground work required by the state.

Maintenance shop, aglime on fields and chloride of roads. New roof on town hall and Nelimark along with inflation on electrical bills (some more usage not all inflation), maintenance and office supplies, fuel, etc. are reasons for the 3.61% increase proposal.

LaMar states an average increase rate is 2.7% for townships our size. Township has done a good job in keeping the budget at low percent. Carefully picking and choosing what is important to the township on such a budget.

Motion/Fowler: Second/ Wright a lot of thought was put into the levy proposal and states that we need to accept an increase and to accept the \$172,000 levy proposal as presented for 2023, Sue Beaton adds with the addition of adding an ambulance fund to the cash report if a decision is to go forward with ambulance service fee. Discussion had; some agree there should be more of an increase in the levy. Discussion started a second time on the ambulance. Moderator LaMar takes control of meeting when discussion when voices become raised. Moderator explains this will be discussed at regular board meetings. Wright speaks this is for the board to decide and the fee could be denied by the board. Mettler speaks about what the fee again would go for which is having the ability of having the ambulance come, the insurance is to maintain the equipment and such. Rhein explains with the township being right in the middle of all these ambulance services, yes more than one may show up. Moderator calls for a vote of the motion made on the levy proposal. Votes: Yays-11. Nays-4. Motion carries.

Clerk thanks those who complimented her on the preparation for the meeting and agenda set up and for levy proposal put in the Flying Finn.

Shireen Lee and Jill Waisanen spoke with the board about reserving the town hall for a Saturday Market they will be hosting. Board approves of the renting of the townhall the first Saturday of May through September to hold the market which will sell goods such as craft items produce and more.

Muhvich requests that Pylka Road be graded once in spring and once in fall, no more unless requested. *Motion/Wright: Second/Mettler to grade once in the spring and once in the fall as asked by Pylka residents. Carried 3-0.*

Wright asks clerk why maintenance is driving down roads daily as he was asked by Sauna Road resident. Response by clerk was to check for any downed trees, holes to be filled, culverts, or anything else on roads and stated this is something that has always been done by maintenance as part of maintaining the township, all township roads not just Sauna Road are checked.

Maintenance Report given by Mettler. Cell phone booster installed at town hall, rink maintained with wood for heating warming shack, shed at rink broke into, Post Office furnace not working on 19th, battery in thermostate replaced. Snow removal on properties, tree removal of downed trees on township roads (Mettler points out why maintenance employees check township roads). Wright put sand down in the restrooms at the info center as floors were reported slippery. Strips, mats, floor paint were all discussed as options to be placed on the restroom floor.

Motion/Wright: Second/Mettler to transfer the funds out of Municipal State Aid and create fund and transfer funds into County State Aid Fund as this is the correct name of the according to State. Carried 3-0.

Clerk informs board the VEGA-3 grant was awarded in the amount of \$1,932.23 little smaller than anticipated because of the high request for required equipment, these grants were lower. Clerk has ordered the DS2000 as requested by the county and approved by board at previous

meeting. DS2000 is required voting equipment to be eligible to be a qualified polling location.

Ambulance Service was discussed. Suggestions to maybe start a committee to get the answers, information, and facts to make the right decision for the township. Topic was tabled as more discussion and information are needed for a decision. Motion/Mettler: Second/Wright to continue to next meeting to be able to read through the information provided and get some facts to base the request on. Carried 3-0.

Clerk informs board that a Little League Manager has come forward to volunteer and has collected all the information and records from the clerk's office. Township Board is thankful to the new manager in the interest of keeping the little league going.

SISU meeting with SISU President has been set for March 15 at 12:30 p.m., after board completes MATTS training. Maintenance Agreement along with tours will be discussed during this meeting, discussion of handing the tours over to SISU as it seems more fit for SISU to operate them. Mike Salo Memorials will be given to SISU to help with tours for the purpose they were given if agreement is met.

Information Center Restroom picnic tables and slab with covered sitting area discussed. Waiting on design and price.

Fair Board request for the \$750 in township labor approved at Annual Meeting also approved by board. Liquor License will be approved when received.

- 2021 Highlights. Sue complied a summary of ERFA accomplishments and highlights for 2021 to present at the Embarrass Township annual meeting. Copies are available upon request.
- Pancake Breakfast. At the February meeting ERFA decided that better advertising is needed to promote the Pancake Breakfast. To that end, Sue showed membership the new Pancake Breakfast display ad that ran in the East Range Shopper. - Annual Request to Township. Sue will attend the Embarrass Township annual meeting to request labor for the Fair weekend. She said that we need to create in advance, a task list of jobs for the Township workers so they can be assigned work upon arrival.
- Lion's Club Beer Tent. (Strong vs 3.2). Since 3.2 beer is no longer available in MN, serving strong beer at the beer tent was approved.
- Vendor Letters for the Grounds, Timber Hall & Food Trucks. Sue announced that the vendor letters have

been mailed out. Michelle suggested using Festival.net as a way to find vendors. She noted that vendors go to the site to schedule events and festivals, and that event organizers can put their applications on the site for vendors to download. Sue and Janine agreed to look into using the site.
