Board Members Present: Mike Johnson, Steve Sipola, Carrie Westvik, Nina Honkola and Sandra Gibson

Visitors: Dave Hess

Meeting was called to order at 7:00 p.m. by Board Chair, Mike Johnson and the Pledge of Allegiance followed.

Minutes Approval: Steve moved to approve the July 7, 2021 Regular Meeting Minutes. Mike supported. Carried (3-0).

Treasurer's Report: Receipts for today: \$710.00 State of Minnesota—Township Aid. Total Disbursements for July 7, 2021: \$48,714.17. Including in the expenditures was payroll, snowplowing, 2 times mowing the cemetery and the yearly fire contract. Mike accepted the Treasurer's Report and Carrie supported. Carried (3-0). Mike approved the transfer of \$1,413.89 from the Building Fund to the Cemetery Fund. Carrie supported. Carried (3-0).

Approval to Pay August Bills: Steve moved to approve payment of the bills listed below plus payroll and PERA with support from Mike. Carried (3-0).

Lake Country Power, \$71.50 Town Hall Electricity

Sipola, Steve, \$19.60, Mileage Reimb.—35 mi.—Monthly Road Inspec.

Address Visitors: Dave Hess stated that he wishes more people would attend the monthly board meetings and that more residents would take an interest in what is done in the township.

Road Report: Steve rode all township roads yesterday and they are in good condition with the exception of Beckman Road as you come off Mesaba, which is a bit wash board-like. Steve will set up the Heikkila Road sign. He did a temporary job recently.

Cemetery Report: Our Sexton, Wally O'Farrell, needs to take an extended leave of absence due to health reasons. Kevin Gibson, former Waasa Sexton, will meet with the board supervisors to give some training

on the position, so that one of them can take over if any burials come up or other cemetery issues.

Old Business: Steve will check into the supplies that will be needed for installing the cemetery and township signs.

New Business: The American Rescue Plan Act (ARPA) application will not be made at this time.

Correspondence: Mail was read and filed.

Adjournment: Mike moved to close the meeting at 8:00 p.m. and was supported by Steve.

1. August minutes were reviewed. Motion to accept Mickey W., second Cindy S., MC.
2. Financial reports for August were presented. Motion Linda K. to pay invoices \$249.13 & \$81.47, second Mickey W., MC. The board approved payment of \$300.88 for (39) Sauna Day T-shirts, Motion David P., second Mickey W., MC.

5. Grant writer Cassandra Hainey will be rescheduled for a later month.
6. Paul K. reported we have approval from LHB to start an application to have the Apostolic Lutheran Church on the church registry. We can review and approve at the next meeting.

Bike Trail signs were tabled till the board makes a choice of designs and wording for (2-4) signs which will be paid for by SISU Heritage.

7. Work started at the Apostolic Lutheran Church. On Sept. 23, the board voted by e-mail to have Greenstone Properties put a concrete footing under the new wall of the Apostolic Lutheran Church. They found there was no footing at all under the old wall, and said we needed one, with our options

being concrete or foundation treated wood. By choosing the concrete footing, we are agreeing to add \$2000 to the bid from Greenstone properties for labor and concrete.

Embarrass Region Fair Meeting Minutes

September 16, 2021

Pending Approval

Present Board: Gustave Schroeder, Jerry Meier, Sue Beaton, Janine Patten Trustees: Floyd Joki, Rodney Dale.

Members Present: Jo Hardy, Holly Johnson, Roland Fowler, Craig Johnson, Sherie Joki, Jill Waisanen, Chris Dale, Lisa Gibson, Shireen Lee, Michelle Epps, Charles Epps, Gene Wright.

Call to Order. Gus called the meeting to order at 6:30 pm.

Minutes: The minutes of the August 19th meeting were distributed to the membership for review. Gus asked for any changes, additions or corrections; there were none. Jo moved to accept the minutes. Floyd seconded. Motion carried.

Treasurer Report:

Two reports were distributed; the monthly financial report showing checking & savings account activity and balances for the period from 8/2/21 through 9/15/21 and the gate admission sales and event entry fees for the 2021 Fair. There was a significant discrepancy between the number of wristbands sold at both admission gates and the amount of cash taken in. Gus asked everyone who worked at the gates, to see if they accidentally took home some wristbands or cash, and to also contact any gate volunteers they know and ask them as well. Gus said that if the discrepancy cannot be accounted for there will be an investigation.

Gus said Jo & Jim did a great job with the Demo Derby and the accounting was "spot on". Gus said we need to work through a few accounting issues with Team Penning. Jerry asked Sherie to provide a breakdown separating the Mud Run entry fees from the ticket sales so he can accurately calculate sales tax. Sherie said she could do that. Jerry said ERFA received a refund for unaired radio ads. He also reported that Fairbook ads brought in \$5,700 (including \$910 in outstanding invoices). Printing cost \$3,805. Shireen said that we need a volunteer recruitment plan and asked how much ERFA spends on recruitment and training of volunteers. Jerry said that currently don't spend money on recruitment or training.

Due to increased costs, Jerry said we need to raise the price of the Pancake Breakfast to \$6. After discussion

among the members, Jerry motioned to raise the price of the Pancake Breakfast to \$6.00 beginning with the October 2nd Pancake Breakfast. Craig seconded. Motion carried.

Jerry made a motion that the price of Fair admission be increased to \$5 beginning in 2022. Sue seconded. Motion carried.

Jerry stated that there are six more people who want to rent storage space than we have space for. In addition, Jerry said we should revisit the per square foot charge for rental storage space for winter 2022-23. Lisa moved to accept the treasurer's report. Sue seconded. Motion carried.

Gus and Janine took a few minutes to read thank you notes from Team Penning/Ranch Sorting, the Fight ALS Committee and Miss Embarrass Region runner-up 2019, Kansas Nean for a scholarship award. Gus also read a note and acknowledged a donation from Gail Esala to the Flying Finn Run in memory of her brother Gene Avikainen. Janine read a letter from the Embarrass Region Volunteer Fire Department stating that they are waiving their fees for the 2021 Fair. The Fair Board and ERFA are grateful to the Embarrass Region Volunteer Fire Dept. for keeping fairgoer's safe with their generous donation of time, materials and equipment.

Old Business

Craft Shows Update. Shireen said she met with Sue & Janine to work on the flyer for the November 6th HandCraft & Bake Sale. She also pointed out that it may be difficult to find crafters because there are several other large craft shows on the same day.

Timber Hall Doors. Shireen suggested putting out a donation bucket at the Pancake Breakfasts to raise money specifically for the Timber Hall doors. Janine said she would make a sign & donation bucket. Other fundraising ideas are tabled until the October meeting.

New Business

Pancake Breakfast. The Pancake Breakfast returns on October 2nd. Jerry went over supplies that need to be purchased.

Timber Hall Update. Jerry said he is going to take bids for snowplowing and that he will put together a request for proposal. Jerry asked for help on Sunday with putting the animal barn away. Gus said he thinks the animal barn gates could be chained together and left outside.

Fair Review. Gus thanked everyone for all they did to make the Fair a success. Several members commented on how good the parade was this year. Sue gave a 'vendor recap' with feedback from food, ground and Timber Hall vendors. Sue also suggested that we fine tune our request for labor from the Township so that in the future volunteers will know when to show up and what to do. Gene Wright said that we could still provide that information for the coming year. Sue suggested that an additional tent and an office copier be put into the 2022 budget. Jerry pointed out that Minnesota does not have 3.2% beer anymore so starting next year we will have to allow strong beer to be sold at the Fair.

MN Dept. of Health Food & Beverage Inspection Report. Sue said that on the first day of the Fair the health department made an unannounced inspection of the Timber Hall kitchen. Sue reviewed the inspection report for the membership. She said that the inspector suggested changing the type of food license we hold from "seasonal permanent food stand" to 'special event food stand'; this license would cost less and not require a certified food protection manager. Sue and Jerry are pursuing this change.

Locking Mailbox for Donations. Shireen suggested ERFA get a locking mailbox for donations. Craig said he thought that using the ERFA PO Box number for donations would be sufficient.

Develop a consistent written volunteer policy (including wristbands). Tabled until the October meeting.

Miscellaneous

Floyd said that longer cords are needed for the PA system. Jerry and others praised the VCC cadets who Sherrie hired for fair security. The cadets did a great job and even helped us take down tables at Timber Hall after the Fair.

Lisa made a motion to adjourn. Jerry seconded. Motion carried. Gus adjourned the meeting at 8:15 pm.
